- 1- Covering Letter
- 2- Invitation Letter or Hotel Reservation "1 copy should be sent directly to the Embassy"
- 3- Bank Statement of the last six months
- 4- 2 recent passport size photographs with a white background
- 5- Copy of CNIC
- 6- Return Ticket
- 7- Affidavit charges Rs.200/-
- 8- Income Tax papers of the last 3 years

Documents required

- ? Two (recent) passport size photographs.
- ? South African visas are issued on payment of a nominal fee.
- ? Covering letter on letterhead about your Job / Business in Pakistan.
- ? Copy of NIC Card.
- ? Bank statements of the applicant for the last 6 months (Not Company).
- ? Computer printout of confirmed return air reservations
- ? Written statement confirming the purpose and duration of the visit on Stamp paper (Original in English).

- ? Confirm hotel booking to be faxed by the hotel in South Africa directly to the Mission & copy on application. (Fax: + 92512250140)
- ? All the previous passports.
- ? Applicants can be requested to lodge a Repatriation guarantee, which will be refunded if the applicant complies with the conditions of the temporary residence permit.
- ? In respect of minor dependent children to accompany the applicant or joining the applicant in the RSA: in the case of a minor subject to guardianship or custody, proof of such guardianship and custody; or
- ? In the case of an unaccompanied minor, consent from the guardian
- ? An applicant for a visitors visa exceeding a period of three months shall, in addition to the above submit:
 - ? Marriage certificate in the case of a married applicant;
 - ? Proof of relationship as contemplated in regulation 3;
 - ? A death certificate in the case of a widowed applicant;
 - ? A decree of divorce in the case of a divorced applicant; and / or
 - ? Proof of legal separation in the case of a separated applicant
- ? An affidavit, substantially corresponding to form 12 contained in Annexure F, confirming any marital status or spousal relationship of the applicant and the particulars of any children born of such marriage or relationship.
- ? In respect of a minor dependent child accompanying him or her to or joining him or her in the RSA.
 - ? An unabridged birth certificate
 - ? In the case of an adopted minor, proof of adoption;
 - ? In the case of a minor subject to guardianship or custody, proof of such guardianship and custody; and / or

Tourism:

- ? A copy of the travel plans and confirmed hotel reservation;
- ? In the event that a South African family or company extended an invitation, the original letter of invitation on a letterhead and an affidavit signed/ stamp by commissioner of Oath in RSA must be submitted with the application. Fax copies will not be accepted;
- ? Student traveling should prove their bonfires and also submit permission that they may be absent from school /

college / university; and With regard to Airline sponsored visits, an accompanying letter stating the exact responsibilities of their staff members and / or dependents.

Business:

- ? An original letter of invitation and a fax sent to the SAHC From the South African Company.
- ? A letter from company / employer giving details about applicant's position in the company, purpose of the visit and period of stay. A brief profile of the company must be submitted; and a recommendation letter from the Local Chamber of Commerce / Export Promotion Bureau.
- ? All applications will be forward in embassy through TCS.

Transit:

- ? A valid onward air ticket. Port of final destination.
- ? If no visa is required, letter of invitation, temporary residence permit

- ? Work permit from destination country.
